Job Essential Elements:

- 1. Must be able to pass a pre-employment drug screen, physical and criminal background check.
- 2. Must be at least 18 years of age or 21 to drive for PSW.
- 3. If required to drive PSW vehicle or personal vehicle for company business, must have and maintain valid California driver's license and DMV record acceptable to PSW insurance. Must maintain current vehicle insurance with a copy on file when using personal vehicle for PSW business.
- 4. Must be able to individually lift 50 pounds from floor level to waist height observing appropriate safety practice when lifting, stooping or bending and in the performance of all other job functions.
- 5. Must be able to use proper two person lifting techniques.
- 6. Ability to respond effectively and have strength and agility to assist with supported individuals who have mobility, behavioral, and/or physical limitations.
- 7. Must work cooperatively with co-workers, individuals, agencies and customers. Must respect their rights, including the right to privacy, dignity, and confidentiality.
- 8. Must be at work when scheduled unless otherwise excused by supervisor.
- 9. Must demonstrate punctuality in the performance of all other job duties.
- 10. Must be able to communicate clearly and concisely, in English, both verbally and in the written form.
- 11. Observe all workshop departmental policies and procedures.
- 12. Operate a variety of modern office machinery.
- 13. Prepare reports, correspondence, and office forms.

Job Duties:

- 1. Obtain and interpret information in terms of the individual's needs and has an understanding of the range of treatment needed for all individuals.
- 2. Develop and maintain a written Restricted Health Condition Care Plan for individuals with a restricted health condition.
- 3. Provide training to all PSW employees that will be participating in meeting an individual's specialized care needs.
- 4. Reviews performance of PSW employees that participate in meeting a individuals specialized care needs as often as necessary, but at least annually.
- 5. Observes individuals, charting and reporting changes in individual's condition such as adverse reactions to medication or treatment.
- 6. Administers prescribed tube feeding supplement formula and other fluids and note times and amount on individual's charts.
- 7. Measures and record individuals' vital signs, such as height, weight, temperature, blood pressure, pulse and respiration.
- 8. Assembles and use equipment such as catheters and tracheotomy tubes, G-tubes, Colostomy bags.
- 9. Teach employees on health care topics such as diabetes.
